

5th International Dance Competition "Città di Ragusa"

RULES

Art. 1

Students of dance schools and dancers of all nationalities can participate in the competition

Art. 2

The competition will take place on Sunday 26 April 2020 at Auditorium San Vincenzo Ferreri, Piazza G.B. Odierna - Ragusa Ibla (RG), Italy

Art. 3

Competitors will be divided into Soloists, Duo and Groups in the following four categories:

- BABY dancers up to 8 years old
- ALLIEVI dancers from 9 to 11 years old
- JUNIORES students from 12 to 14 years old
- SENIORES students from 15 to 17 years old
- PRE-PROFESSIONAL from 18 years onwards

Only for Pre-professional category will not allowed Groups Choreography (eventually consider to participate at Choreography Composition)

Art. 4

The following dance styles are allowed:

- A section : Classical
- B section : Contemporary
- C section : Modern, jazz, lyric.
- D section : Character

Art. 5

The jury will consist of dancers and choreographers of clear fame, The jury's judgment is absolutely unquestionable.

Art. 6

Groups should be composed of 80% of dancers belonging to the age range indicated in the category of membership

Art. 7

The duration of the music track will not exceed 5 minutes for the groups, 4 minutes for the Duo and 3 minute for the soloists. A tolerance of 15 seconds is allowed beyond which the song will be faded.

Art. 8

Each track must be send together with the application form. Each song must be on mp3 format and must be named as follow:

1. soloist:

- Category_Section_ Name(age)_title (length min.sec)

Es: Allievi_Contemporary_Serena Iannizzotto(10)_Sorella Povertà (3.00)

2. Duo or groups:

- Category_Section_ title(n°of dancers)_ (length min.sec)

Es: Juniores Groups_Classical_ Flower Waltz(15)_ (4.50)

However it is advisable to bring one copy of the music in a cd or mp3 format to be delivered in usb key.

Art. 9

Any scenic objects should be removed immediately after use on the stage. It is absolutely forbidden to launch confetti, sparkles and anything else that can dirty or slip the stage. The useful dimensions of the stage are: 10.00 m (depth), 12.00 m (width).

Art. 10

Prizes: scholarships, trophies, special prizes that will be communicated with a special statement.

Art. 11

The jury may not award all prizes

Art.12

The organization assumes no responsibility for any damage to persons or things that may occur during the event, whether they occur or caused by people participating in the show.

Art. 13

The organization, if it considers it necessary, may modify, replace, delete or add one or more of the following articles, whether in hard copy or on-line.

Art. 14

A large media relevance will be given to the event

Art. 15

Votes and rankings will be made available immediately after the end of the competition.

Art.16

Costs:

- Soloists: € 50,00
- Duo: € 80,00
- Groups: € 20,00 for each dancer

Art. 17

If you intend to participate with choreographic works deposited at S.I.A.E. or to a similar collective management company with which SIAE has entered into agreements on the collection of copyright in Italy, the communication must necessarily take place 15 days before the competition starts, in order to verify the correctness of the data provided and in order to obtain the necessary authorization and the related compensation for the payment of copyright

Art.19

With reference to L. 31/12/96 N.675, from the time of acceptance of this regulation you authorize the ASS.CULT.SPORTIVA DILETTANTISTICA PROGETTO DANZA to deal and process the personal data for the operations connected to the event called Dance Competition "Città di Ragusa". With reference to Legislative Decree No. 196 of 30/06/2003 and subsequent amendments and additions from the acceptance of this Regulation, ASS.CULT.SPORTIVA DILETTANTISTICA DANZA PROJECT DANCE is authorized to processing the personal data received for registration and the possible dissemination of images, video and audio in order to promote the cultural and sports initiatives of the aforementioned association, without requiring any repayment of any kind and without any form of remuneration. Art. 20

Art.21

By signing up at the event called Dance Competition "Città di Ragusa ", the School Manager declares that the medical certificates of all the dancers registered in the competition are in possession of the school, and that he has the whole responsibility and that the participants in the event have been carefully visited by a physician who has established physical fitness to attend the event. Such certificates can be requested from the organization at any time.

Art. 22

The registration of the competition implies the acceptance of the above-mentioned regulation, in all its parts and article.

Art. 23

As far as not explicitly described in this regulation, reference will be made to the Civil Code. The Court of Ragusa is competent for any dispute
